This information provided within this document relates to the conformity of Camira Fabrics Ltd. contract fabric ranges to the following U.S. regulatory requirements;

- AB 2998: Consumer products: flame retardant materials
- Safe Drinking Water and Toxic Enforcement Act of 1986 also known as 'Proposition 65'
- AB 2247: Consumer goods containing Perfluoroalkyl and polyfluoroalkyl substances (PFAS)

**AB 2998: Consumer products: flame retardant materials**

[AB-2998](#) prohibits the sale and distribution of new juvenile products, mattresses and upholstered furniture that contain specified flame retardants. Effective from 1<sup>st</sup> January 2020 the Act prohibits sale, offer for sale and distribution in the State of California of new juvenile products, upholstered furniture, replacement components of reupholstered furniture, and the foam in mattresses (collectively referred to as "covered products") that contain covered flame-retardant (FR) chemicals at levels above 1,000 parts per million (ppm).

The information provided in Table 1 & 2 outline which fabrics within the Camira contract portfolio including post treatment options contain FR chemicals that exceed 1,000 ppm. All fabrics that do not exceed 1,000 ppm are marked 'No' and therefore comply to the requirements outlined within AB-2998.

**Safe Drinking Water and Toxic Enforcement Act of 1986 also known as Proposition 65**

Proposition 65 became law in November 1986. The official name of Proposition 65 is the [Safe Drinking Water and Toxic Enforcement Act of 1986](#), and requires businesses to provide warnings to consumers about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm.

The information provided in Table 1 & 2 outline which fabrics within the Camira contract portfolio including post treated options contain any regulated toxic and/or carcinogenic substance, found in the chemical list outlined by Proposition 65. All fabric options marked 'No' comply to the requirements outlined within Proposition 65.

## **AB 2247: Consumer goods containing Perfluoroalkyl and polyfluoroalkyl substances (PFAS)**

In a continuing effort to address concerns surrounding consumer goods containing perfluoroalkyl and polyfluoroalkyl substances (PFAS), the California legislature passed [AB 2247](#) on Aug. 30, 2022. If the measure becomes law, it will require manufacturers to collect information on and publicly register all products or product components containing PFAS that are sold or imported into the state of California on or before July 1, 2026.

The information provided in Table 1 & 2 outline which fabrics within the Camira contract portfolio including post treated options that contain Perfluoroalkyl and polyfluoroalkyl substances (PFAS). All fabric options marked 'No' comply to the requirements outlined within AB 2247.
