OEKO-TEX® Certification Update for Xtreme and Urban

Recent updates to the OEKO-TEX® STANDARD 100 criteria have led us to re-engineer the flame-retardant technology used in our Xtreme and Urban fabrics.

As a result, during a transition period you may see two OEKO-TEX® certificates associated with these fabrics:

- **Class 2 Certificate**

Applies to the re-engineered versions, developed to meet the more stringent Class 2 OEKO-TEX® requirements.

- **Class 4 Certificate**

Applies to fabric produced utilising raw materials inventories held in legacy supply chains and finished goods materials held in inventory, which remains fully compliant within its designated OEKO-TEX® STANDARD 100 classification.

This dual-certification approach ensures full transparency while allowing us to maintain a continuous supply of certified fabric throughout the transition. Both the existing and re-engineered versions have been rigorously tested and verified to meet all applicable OEKO-TEX® STANDARD 100 criteria for their respective classes.

Understanding OEKO-TEX® STANDARD 100 Classes

Class 2 – Products with direct skin contact

- Intended for textiles that come into direct and prolonged contact with skin. Typical examples include apparel, bed linen, towels, T-shirts, underwear and everyday wearable products.
- Testing limits are more stringent than Classes 3 and 4, reflecting frequent skin contact (though less strict than Class 1 for baby products).

Class 4 – Furnishing and decorative products

- Intended for textiles with little or no direct skin contact. Typical examples include upholstery, curtains, wallcoverings and decorative fabrics.
- Testing limits are less strict than Class 2, reflecting the intended end use.

Key distinction

- **Class 2:** Stricter limits due to regular, prolonged skin contact.
- **Class 4:** Appropriately adjusted limits where skin contact is minimal.

Both classes confirm that fabrics are free from harmful substances at levels considered safe for their intended applications, with thresholds aligned to real-world use.

Where Class 2 is an absolute requirement for your application, please ensure this is stated clearly on your purchase orders.

Fabrics may be produced with fibres accepted by OEKO-TEX® having flame retardant properties. In fabric qualities: Xtreme, Urban, X2, Lucia T2T, Gravity, Oceanic, Quest, RePlay, RePlay Zero, Big Arrow, Manhattan, Lumis Halo, Lumis Astro, and Lumis Nova. Exclusively produced using components pre-certified according to OEKO-TEX® STANDARD 100.
